HOLD HARMLESS, WAIVER AGREEMENT ASSUMPTION OF RISK AGREEMENT

I hereby release, waive, discharge and covenant not to sue the SAAGH, its officers and directors or agents (Releasees) from any liability, claims, demands, actions, causes of action whatsoever, arising out of or related to any loss, damage or injury, including death, that may be sustained by me or my property, caused by any negligence of any Releasee, while participating in this event. I fully assume all risks for any activity I may engage in during this event.

I further hereby agree to fully indemnify and hold harmless the Releasees from any loss, liability, damage and all direct and indirect costs, including without limitation court costs of any type whatsoever and attorney fees, that such Releasees may incur due to my participation in this event, even if caused by the negligence of Releasees.

It is my express intent that this Hold Harmless, Waiver Agreement and Assumption of Risk Agreement shall bind the members of my family and spouse, if I am alive, and my heirs, assigns and personal representative, if I am deceased, and shall be deemed as a release, waiver, discharge and covenant not to sue any of the Releasees.
